## 2.- EURODEFENSE organisation and functioning

## **2.1.-** National associations.

## 2.1.1.- EuroDéfense-Italia

Professor Fabrizio W Luciolli had been invited to participate at the Presidents Council as an observer. Vice-president of the Italian North Atlantic Treaty Association, professor at the Italian higher defence studies centre(CASD), he is very much involved in defence matters. He has contacted ambassador

P. Calamia. The general Chief of Defense Staff is in favor to "recreate" EuroDefense-Italia. It should be done for the beginning of 2018.

### 2.1.2.- EuroDéfense-Grèce

President Theodossis Georgiu had apologized for not being able to participate at this Council where he had intended to be present.

### 2.1.3.- EuroDéfense-Luxembourg

Unfortunately, EuroDéfense-Luxembourg had not answered any attempts at making contact.

#### 4.1- Permanent groups/Observatories

#### 4.1.1- Mediterranean basin Observatory

EuroDéfense-Espana has presented a situation report. It will be posted on the website

#### 4.1.2- EURODEFENSE website

. EuroDefense-France has presented its report. EuroDefense-UK and EuroDéfense-France proposed some improvement:

- Use the social networks (Twitter and Facebook)

- Try to use DROPBOX for the reports building and put all the agreed documents on the website by creating links between existing sites; so it should be easier to look at those sites whose archives are updated.

## 4.1.3.- EWG 17 (ED-UK) "Cybersecurity"

The report proposing a "Code of conduct" was sent to the EU authorities in 2016. EuroDefense-UK has proposed to write a new mandate for a working group taking into account the presentation made at RUSI meeting.

#### 4.1.4.- EWG22 (ED-Deutschland) Migrant and refugees

EuroDéfense-France has presented a situation document. EuroDefense-Deutschland propose, in the next two months, a proposition document for the security domain.

#### 4.1.5.- Arctic (ED-Deutschland)

EuroDefense-Deutschland will soon propose a situation document.

#### 4.2.- EURODEFENSE Working Groups (EWGs)

#### 4.2.1.- EWG 18 (ED-France) - EDEM - EDTIB

The EWG 18 report has been addressed to the EU authorities after the Paris Council, and receive an answer from the Commission. The Commission recognize the financing necessity on European funds for some Research and Development in the Defense industry domain.

EWG18 is closed, but EuroDéfense-France keep in contact with some Commission members to keep an eye on the sitution evolution.

#### 4.2.2.- EWG20 (ED-AU) - EU-Russia relationship

. The report has been sent to the EU authorities last July.

EuroDéfense-France is instructed to get in touch with the EEAS or the EU Council Secretariat to organize a an oral presentation, if possible with Mrs. Mogherini.

#### 4.2.3.- EWG23 "Training and Simulation" (ED-NL)

After taking into account the amendments to the report agreed during the Council, EuroDefense-Nederland will circulate it under silence procedure.

#### 4.2.4.- EWG24 "Permanent structured cooperation" (PESCO)(ED-FR)

The report proposing participation criteria to PESCO for Member States has circulated before the Council. ED-France will circulate the amended version under silence procedure in view to send it to Brussels as soon as possible.
